The **Paycheck Protection Program** (PPP) provides potentially forgivable loans to small businesses to help them keep their workers on the payroll and pay certain essential business expenses for a limited period of time. On December 27, 2020, the President signed the Economic Aid to Hard-Hit Small Businesses, Nonprofits, and Venues Act (the Act). The Act creates a March 31, 2021 deadline for submitting a PPP loan application. Certain small businesses that previously obtained a PPP loan may be eligible to obtain a second PPP loan. The Small Business Administration is in the process of writing the rules for the new program. Frequently asked questions are available **here**.

We will consult with interested Black businesses and help gather the necessary material, choose the appropriate lender, and prepare and submit the application.
