She has argued cases before several United States Circuit Courts of Appeals as well as successfully defended against a petition for certiorari before the United States Supreme Court.

She has presented hundreds of cases before the West Virginia Occupational Pneumoconiosis Board, a three physician panel. Because of her experience, Ann has addressed an Annual Training Conference of the Office of Administrative Law Judges providing the defense perspective of litigating federal black lung cases. She has also presented to the West Virginia Self-Insured Association regarding workers' compensation issues affecting employers who are self-insured for their workers' compensation liability.
